**Position:** Tenure-Track Assistant Professor position with a primary specialization in one of the following areas: Sociology of the Family, Sociology of Gender, or Sociology of Sexualities. Secondary area of specialization is open.

**Starting Date:** August 2017

**Minimum Qualifications:** Ph.D. or ABD in Sociology or a related field. The appropriate doctorate is required for retention beyond the first year of employment.
